REQUIREMENTS. Every notary applicant must meet all of the following requirements:. Must be at least 18 years of age; Must be of good character and reputation - Individuals convicted of a felony who have not had their rights restored as well as applicants convicted of a crime involving dishonesty or moral turpitude are not eligible for a Delaware notary commission.
